# III. Virginia State Bar Members' Insurance Center Quarterly Update – Debbie Stocks, VSBMIC Senior Client Executive

A copy of the VSBMIC report, dated January 30, 2023,was included in the meeting materials. The report was presented by Debbie Stocks as follows:

- Meeting attendance Jennifer Stevens attended the following meetings/events: Loudon County Bar Association Meeting (Nov 16), Henrico County Bar Association (Dec 8), Metro Richmond Women's Bar Association (Dec 9), Newport News Bar Association (Jan 11), Williamsburg Bar Association (Jan 12).
- Planned events for 2023:
  - VSB Annual Meeting, Virginia Beach. Opening reception Diamond sponsor \$10,000.
  - CLE Presentations requested by Loudon County Bar Association (HR Consulting – Hiring trends and retaining quality employees)
  - o VTLA and VADA annual conferences
  - o Civility Cup golf event
- Health Insurance Currently there are no major changes planned for our industry. 2023 rate increases are significantly higher in the small group market than 2022, with trend at 9-11% but many plans seeing 15-20%.
- Q4 2022 Assisted 41 small firms with sole proprietor or small group medical plans, over 20 individuals with Marketplace medical plans.
- Disability insurance Sun Life (who purchased Assurant) is the current carrier for the VSB long term disability insurance plan
- Life Insurance (Prudential) We completed our fall mailing to VSB members under age 60 and added 111 new insureds to the VSB group plan. Letters to VSB members with President Stephanie Grana's signature is greatly appreciated. Stephanie is the sixth VSB President to assist with this life insurance letter. See attached report with life applications coinciding with VSB member letter.
- Enhancements to the VSB Members' Group Life Plan with Prudential:
  - New "Life Express" for members under age 40. Allows members to apply for up to \$200,000 with MIB & Pharma lookup only required for approval (no other underwriting). Amounts over \$200k subject to simplified or full underwriting.
  - Prudential "short form" simplified underwriting for members under age 60.
  - Considering new AD&D to be available to all new applicants AND current members of the VSB group life plan.
- Enhancements to billing services:
  - o Currently offer paper billing and/or auto payment with ACH.
  - No later than Q2 will offer online payment function.

Please allow me to provide an update on VSBMIC operations:

- Meeting attendance Jennifer Stevens continues to attend local bar meetings/events around the Commonwealth.
- VSB Annual Meeting, Virginia Beach. One Digital was once again the Opening reception Diamond sponsor.
- Health Insurance Anthem plans to terminate the Association Value-Added benefit of \$10k life insurance for each employee on an "association" small group employer plan as of February 1, 2024. Anthem will notify clients in Q4 2023.
- Life Insurance (Prudential) We are preparing our fall mailing to VSB members. This mailing will include a link for online enrollment as well as a paper application and information re: the new guaranteed issue life insurance and AD&D benefits.
- <u>New Critical Illness</u> group policy proposed as requested by VSB Insurance Committee member. Cameron Rountree reviewed VSB rules and regulations re: offer of new benefits to VSB members. Debbie spoke with VBA executive, Paul Fletcher, re: new benefit offerings.
  - The proposal was reviewed by VSB Lawyer Insurance Committee at the May 18 meeting. <u>Request approval of committee to offer this</u> <u>new benefit to members in 2024</u>.
  - Critical Illness will help cover 14 conditions including: cancer, stroke, heart attack, Alzheimer's, severe coronary artery disease and major organ failure, among others. \*

- Guaranteed issue to \$10,000 per occurrence. Max benefit is \$40,000 per occurrence. Initial and annual open enrollments with no EOI (evidence of insurability). \*
- Average monthly premium for GI amount ages 25-64 years is \$11.45 with 3-year rate guarantee. Premiums are age banded. Minimum 25 participants. \*
- Product offering and roll out dates TBD.

- \*These are a few brief benefits. Prudential brochure will be available to members with full details.
- Change in TPA and enhancements to billing services:
  - Currently offer paper billing and/or auto payment with ACH.

  - Improves member experience with one application and underwriting step. Apply online or with a paper application. (SunLife only offers paper application)
  - Enhancements to LTD plan include COLA with all plans to age 65, limited Guaranteed Issue with an open enrollment, small rate reduction.

### Virginia Risk Management Report

## 2023 Q2

 On–Demand Programing: Currently, 28 programs exist in the Virginia on-demand library. They range in length from 60-min to three hours. Charges for on-demand seminars are as follows: one-hour programs are \$40 for ALPS policyholders, \$70 general; two-hour programs are \$50 for ALPS policyholders, \$80 general; and three-hour programs are \$70 for ALPS policyholders, and \$100 general.
