## VSB Study Committee – Topics for 2<sup>nd</sup> Meeting (May 14, 2024)

### **Mission Statement\***

To examine and raise awareness of the declining number of lawyers practicing in Virginia, resulting impacts on the population and economy of the Commonwealth, particularly in geographic areas that may be described as "legal deserts," and to make recommendations to address these trends, mitigate adverse impacts , and improve access to legal services , the legal profession and the justice system for all Virginians.

### Scope of Work\*

- Examine trends in the Virginia lawyer population to better understand the demographics and legal practice areas of Virginia State Bar members, including their changes over time;
- Define and characterize <u>"Virginia legal deserts</u>," and highlight the impact\_of the distribution and makeup of practitioners on access to legal services and access to justice, including developing trends in the same;
- Analyze and determine how best to publicize VSB membership information and related trends, including declines in new attorney bar admissions, anticipated retirement of senior lawyers, and related impacts on the VSB and the health of the profession\_and the justice system;
- Develop accessible and readily implementable recommendations to grow the population of Virginia attorneys statewide and in underserved locations, including ways to attract and retain Virginia lawyers to work in at-risk geographic areas; and
- Identify regulatory reforms, legislative actions, and other potential solutions to increase attorney numbers and mitigate the impacts of "legal deserts" and refer them to stakeholder groups for development and implementation as appropriate

### **Research Initiatives**

- Virginia Admissions & Attorney Volume
  - o Identify and invite guests to initial meetings to help inform direction/priorities
    - VSB staff to present on membership information and available data

- Guest speakers recommended by subcommittee members and others
- Possible survey/outreach to VSB members to gather additional demographic and practice information as needed and appropriate.
- Gather and analyze relevant law school statistics (going back 10 20 years)
  - Application rates
  - Admission rates
  - In-state vs. out-of-state students
  - Graduation rates
  - Bar exam statistics
- o Conduct law student focus groups/surveys to understand why/why not Virginia
- Strategic outreach to ABA/VBBE as appropriate
- Develop maps and infographics
  - Illustrating attorney movement in/out of the state
  - Illustrating law student movement in/out of the state (VA law grads that leave and stay)
  - Illustrating size and distribution of Circuit 33 membership
- Legal Deserts
  - Define important terms
    - "Virginia Legal Deserts"
      - The standard "legal desert" definition, developed by the ABA, is a *county* with fewer than one attorney per 1,000 residents.
      - VSB typically tracks and reports lawyer numbers by circuit of record, not by county/city – discuss/consider VSB's response to the Legal Evolution analysis that uses the ABA definition? Does it overstate the problem? Misapprehend the problem?
      - A single circuit can have rural, suburban, and urban areas within it, so the population density (of residents and attorneys) can vary greatly across a circuit.
      - Active lawyers may practice is circuits outside of their circuit of record, but that is not something the VSB tracks outside of the Virginia Lawyer Referral Service (VLRS)
    - "Rural," "Suburban," and "Urban"
      - US Census Bureau definitions
      - Other definitions to consider see Legal Evolution analysis which includes a "frontier" classification
    - Other important terms
  - Identify and invite guest speakers to present at initial meetings to inform direction/priorities.
  - Assign members to contact <u>data and analysis sources</u> such as Weldon Cooper Center, LSC, VCU, VSU, ODU, and resources and people recommended by Matthew Burnett at American Bar Foundation.
  - Plan and Host Local Field Hearings
    - Two per month starting in July, finishing before Thanksgiving 2024
    - Initial Outreach

- Draft and with local bar associations distribute stakeholder survey/prompt questions
- Develop and publish public service ads
- Attendees
  - Committee members attend as possible, but we will need at least three committee members at each
  - Invite stakeholders that submit useful or compelling comments to speak in person.
  - Members of attending public will be notified about field hearings through public service ads; those who fill out speaker request log will be invited. to speak but guided/controlled as to subject matter.
