# VSB Section Registration Form for VLRS Panelists

Sections of the Virginia State Bar function as separate groups having interests in particular substantive areas of legal practice. Typically, sections sponsor seminars (in conjunction with Virginia CLE), publish newsletters that impact information specific to your legal specialty, and sponsor other activities open to its members.
