Whereupon the defendant waived arraignment and tendered his plea of guilty to 13 counts of Procure Minor for Obscene Material by Communication System as charged in Indictments #1 through #13 and 13 counts of Attempt to Commit Indecent Liberties with Child Under Age 15 as charged in Indictments #14 through #26.
