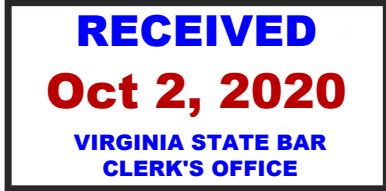

AFFIDAVIT DECLARING CONSENT TO REVOCATION

I, Evelyn Ann Miller, after being duly sworn, state as follows:

1. I was licensed to practice law in the Commonwealth of Virginia on September 14, 2016.

2. I submit this Affidavit Declaring Consent to Revocation pursuant to Rule of Court, Part 6, Section IV, Paragraph 13-28.

3. My consent to revocation is freely and voluntarily rendered. I am not being subjected to coercion or duress, and I am fully aware of the implications of consenting to the revocation of my license to practice law in the Commonwealth of Virginia.

4. I am aware that there is currently pending a complaint, an investigation into, or a proceeding involving, allegations of misconduct, the docket numbers for which are set forth above, and the specific nature of which is here set forth:

From 2015 to September 2018, I was employed at Monarch Title Agency’s Friendship Heights Branch office in the District of Columbia. My primary role was conducting or managing live settlements.

In addition to working for Monarch, I had my own law firm called the Law Office of Evelyn Miller (“LOEM”). I maintained two checking accounts associated with LOEM.

In 2017, I was the settlement agent and/or supervisor of junior settlement agents for six settlements in which funds were required to be held in escrow for an extended period post-settlement. The total amount of escrowed funds across the six transactions was more than \$250,000.

In each such settlement, the affected customers directed Monarch to forward the funds for long term escrowing. Instead of holding these funds in a designated escrow account, these funds were wired directly from Monarch to my LOEM checking account. For four of the six transactions, some or all the funds that were supposed to be held in an escrow account were spent.

All the funds identified by the Virginia State Bar that should have been held in escrow, but were instead transferred to an LOEM checking account, have been repaid. I have also terminated the signature authority of the co-signer on LOEM's bank accounts.

5. I acknowledge that the material facts upon which the allegations of misconduct are predicated are true.

6. I submit this Affidavit and consent to the revocation of my license to practice law in the Commonwealth of Virginia because I know that if the disciplinary proceedings based on the said alleged misconduct were brought or prosecuted to a conclusion, I could not successfully defend them.
