CONSENT ORDER OF IMPAIRMENT SUSPENSION

WHEREAS the Virginia State Bar, by Tenley Carroll Seli, Assistant Bar Counsel, requests entry of an order suspending the license to practice law in the Commonwealth of Virginia of Jennifer Grace Smyrnos ("Respondent") on the basis that Respondent has an Impairment as that term is defined in Part Six, Section IV, Paragraph 13 of the Rules of the Supreme Court of Virginia; and

WHEREAS Respondent acknowledges and represents that she is suffering from an Impairment as that term is defined in Part 6, § IV, ¶ 13 of the Rules of the Supreme Court of Virginia; and

WHEREAS Respondent and Kyle Elizabeth Skopic, guardian *ad litem* for Respondent, consent to entry of an order suspending Respondent's license to practice law in the Commonwealth of Virginia on the basis that Respondent has an Impairment as that term is defined in Part 6, § IV, ¶ 13 of the Rules of the Supreme Court of Virginia and that the underlying condition materially impairs Respondent's fitness to practice law; and


WHEREAS the Virginia State Bar Disciplinary Board hereby finds that Respondent suffers from an Impairment as that term is defined in Part 6, § IV, ¶ 13 of the Rules of the Supreme Court of Virginia and that the underlying condition materially impairs Respondent's fitness to practice law.

Based on the foregoing and the consent of Jennifer Grace Smyrnos; Kyle Elizabeth Skopic, guardian *ad litem* for Respondent; and the Virginia State Bar, and it otherwise appearing proper to do so, it is hereby ORDERED, pursuant to Part Six, Section IV, Paragraph 13-23 of the Rules of the Supreme Court of Virginia, that Jennifer Grace Smyrnos's license to practice law in the Commonwealth of Virginia shall be and hereby is SUSPENDED indefinitely upon entry of this Order due to Impairment and shall remain suspended until it is established that she no longer suffers from an Impairment.

It is further ORDERED that the Clerk of the Disciplinary System shall send a certified copy of this Order by certified mail to Jennifer Grace Smyrnos, Respondent at 118 Townsend Street, Grass Valley, California 95945, her last address of record with the Virginia State Bar; to Kyle Elizabeth Skopic, guardian *ad litem* for Respondent, at P.O. 




